Persons with disabilities should send a copy of the ADA documentation. Persons with ADA documentation have priority assignment for handicap seats. A doctor's notice may suffice for ADA documentation. All other inquiries for ADA seating will be reviewed on a case by case basis. The CIAA will not refund customer payment for cancellation of request, by the Holder or Holder's designee. The Holder is the person whose name appears on the request. The designee is the person acting on behalf of the Holder.
